Student Art Competition Terms & Conditions



GENERAL

1. Art Competition 2020 is open to all students of primary and secondary schools in the Blanchardstown and District Credit Union (BDCU) common bond area (D15 area, approx.).
2. Art competition is open to both members and non-members of the Credit Union.
3. There are two age groups for entrants and prizes will be distributed in each age group:
 - 1) 7-12 (younger)
 - 2) 13-18 (older).
4. The age of an entrant will be taken as their age on the closing date for the competition.
5. Competition opening date is 18th March 2020 and **closing date for entries is 25th April 2020**.
6. All entries must be submitted in the office of Blanchardstown & District Credit Union, Unit 9/10 Blanchardstown Business Centre, Clonsilla Road, Blanchardstown, Dublin, D15 FP92.

ARTWORK

7. The theme is: 'Blanchardstown & District Credit Union – A pillar of our growing community'. There is no need to write the theme on the artwork; the artwork is to reflect the theme idea.
8. All fine art media allowed e.g. oils, acrylics, watercolours, pastels, pencils, pen&ink, poster paints, collage. Please note that digital art is not permitted in this competition.
9. Entries should be A3 (29.7cm x 42cm) in size and may be in portrait or landscape form.
10. All entries need to have written the following **details at the back of their artwork: Entrant/Student Full Name, Age, Class, School, Parent/Guardian Full Name, Phone No, Email, Parent/Guardian Signature**

PRIZES

11. The Art Competition prizes are three Blanchardstown Centre Gift Cards for the amounts of: €150, €100 and €50 for each of the two age groups.
12. Judging will be carried out by independent local artists and representative of the BDCU. The decision will be final and no correspondence will be entered into in this regard.
13. The two first place winners will have their artwork framed and hung in BDCU's office.
14. There will be an exhibition of all entries organised in June/July 2020.
15. The Art competition winners will be announced on 18th May 2020 and all winners will be notified personally, through their parent/guardian.
16. The Art Competition results will be published on the BDCU website, in the office and on social media accounts.
17. A Presentation will be made to the winners for this occasion. Photographs taken at this occasion may be published in local media, used for internal publication including display within the Credit Union, for web material or other Social Media; permission will be sought from the entrants' parents/guardians.

OTHER

18. By participating each entrant, and/or their parent/guardian, agrees to their details (name and age) being used in promotional material for BDCU.
19. Entries for the competition will automatically become the property of BDCU and may be featured in BDCU's promotional material (print and digital).
20. Children of BDCU staff, management and volunteers are not eligible to enter the competition.
21. If there is insufficient support by entrants, the Art Competition may be suspended or discontinued at any time.
22. The decision of the Board of Directors concerning the interpretation of the foregoing rules in matters pertaining to the draw will be final.
